\*We reserve all rights to refuse exchange or return due to damage to the instrument. Damage will be determined by Dr. Dave's Band Aide.

**Liability:**

The lessee agrees to accept full responsibility for the instrument while on rental. If the instrument is lost, stolen or damaged beyond repair( As determined by Dr. Dave's Band Aide) the Lessee agrees to pay the balance due at the time for purchase of the instrument. All instruments remain property of Dr. Dave's Band Aide until final payment and all fees are paid. Bankruptcy of lessor does not eliminate debt.

**Terms and Agreements:**

I/We understand and agree that any credit granted shall be paid promptly in accordance with the terms and agreements.

that the credit grantor may add \$5.00 per month late fee to any balance owed and in the event of default, to pay reasonable collection fees and/or attorney fees.

A \$30.00 late charge will be added if 30 days late

If 45 days late, the contract is terminated and the instrument must be returned or we will collect the instrument, all rental fees, late fees and expenses.

The credit grantor also may pick up the instrument directly from the school or home upon default of any payment.

The instruments shall not leave the school district of the school cited above without notification.

This program is designed for 5<sup>th</sup>, 6<sup>th</sup>, 7<sup>th</sup> beginning band programs only.

Three (3) late payments make this contract null and void and the instrument must be returned to the lessor.

The balances, all costs, fees and penalties will be sent to collection and all payments forfeited.
